Sir,

I am directed to refer to this Ministry's letter of even number dated 7th August, 2008, on the subject mentioned above and to convey the approval of the competent authority to release an amount of **Rs. 1134.63 Lakhs** (Rupees One Thousand One Hundred Thirty Four Lakhs and Sixty Three Thousand only) of Central Assistance for Village relocation in the **Panna Tiger Reserve, Madhya Pradesh** during current financial year 2008-09. This is addition to this Ministry letter of even number dated 31st March 2009 vide which an amount of Rs. 390.00 Lakhs (Rupees Three Hundred Ninety Lakhs only) was released.

2. The terms and conditions governing the above release are the same as given in paras 3, 4 and 5 of the sanction letter of even number dated 7th August, 2008.

3. In accordance with the revised procedure, the Central Account Section, Reserve Bank of India, Nagpur, may kindly be advised to pass credit to the books of the State Government of **Madhya Pradesh** under intimation to this Ministry.

Environmental Forestry and Wildlife – Wildlife Preservation, 3601.04.659.03- Project tiger, 3601.04.659.03.00.31- Grants-in-aid for the year 2008-09 (Plan).
