Sir,

I am directed to refer to this Ministry's letter of even number dated 21<sup>st</sup> August, 2008, on the subject mentioned above and to convey the approval of the competent authority to release an amount of Rs. 63.325 Lakhs (Rupees Sixty Three Lakhs Thirty Two Thousand and Five Hundred only) being the second and final installment of Central Assistance for Sundarban Tiger Reserve, West Bengal during current financial year 2008-09.

2. The terms and conditions governing the above release are the same as given in paras 3, 4 and 5 of the sanction letter of even number dated 21<sup>st</sup> August, 2008.

The expenditure involved will be met from within the Sanctioned Budget Grants of Centrally Sponsored Project tiger Scheme under Demand No. 29, Ministry of Environment and Forests, Major Head 3601 – Grants-in-aid to the State Governments, 3601.04- Grants-in-aid for Centrally Sponsored Plan Scheme, 3601.04.659- Environmental Forestry and Wildlife – Wildlife Preservation, 3601.04.659.03- Project tiger, 3601.04.659.03.00.31- Grants-in-aid for the year 2008-09 (Plan).
