I am directed to refer to this Ministry's letter of even number dated 16th September, 2009, on the subject mentioned above and to convey the approval of the competent authority to release an amount of **Rs. 98.437 Lakhs (Rupees Ninety Eight Lakhs and Forty Three Thousand Seven Hundred only) (Rs. 71.467 Lakhs for Dhdhwa and Rs. 26.97 Lakhs for Katerniaghat)** being the second and final installment of Central Assistance for Dudhwa Tiger Reserve including Katerniaghat Wildlife Division Uttar Pradesh during current financial year 2009-10.

2. The terms and conditions governing the above release are the same as given in paras 3, 4 and 5 of the sanction letter of even number dated 16th September, 2009.

3. In accordance with the revised procedure, the Central Account Section, Reserve Bank of India, Nagpur, may kindly be advised to pass credit to the books of the State Government of Uttar Pradesh under intimation to this Ministry.

The expenditure involved will be met from within the Sanctioned Budget Grants of Centrally Sponsored Project tiger Scheme under Demand No. 29, Ministry of Environment and Forests, Major Head 3601 – Grants-in-aid to the State Governments, 3601.04- Grants-in-aid for Centrally Sponsored Plan Scheme, 3601.04.659- Environmental Forestry and Wildlife – Wildlife Preservation, 3601.04.659.03- Project tiger, 3601.04.659.03.00.31- Grants-in-aid for the year 2009-10 (Plan).
