Sir,

In continuation of this office letter of even number dated the 27th September, 2010 on the subject mentioned above, I am directed to convey the sanction of the President to the payment and release of an amount of Rs. **50.80 Lakhs (Rupees Fifty Lakhs Eighty Thousand only)** being the balance of first installment to central share towards the Grants-in-aid to Government of Mizoram during the current financial year 2010-11. Earlier this, amount was adjusted in the first release being previous balance of 2009-10.

2. The terms and conditions governing the above release are the same as given in paras 3, 4, 5 and 6 of the sanction letter of even number dated 27th September, 2010.
